Approve, authorize and direct the City Manager to execute amendment no. 3 to a Contractual Services Agreement between the City of Fontana and RNL Design to provide programming, architectural design, engineering, landscape architecture, construction plans and documents, construction bidding and construction administration services, and provision of owner supplied items and specialized art installations for the Lewis Library and Technology Center in the amount of \$1,904,680 plus a 10% contingency amount of \$190,468, with a not to exceed overall contract amount of \$6,965,206.
