Approve, authorize and direct the Executive Director to execute Amendment No. 1 to a Contractual Services Agreement between the Redevelopment Agency and RRM Design Group to provide continued support through construction for Phase 2 of the Façade Rehabilitation Program in the Downtown Area in an amount not to exceed \$15,000.00 for a total not to exceed contract amount of \$175,000.
