I have read the Athletic Fields Policies, Ordinance 19.1 and hereby accept the responsibility of adherence to the policies by my group. I further understand that all parks and facilities are rented on an "as is" basis, and that no guarantees are made as to the availability of amenities.

The user group under permit assumes financial responsibility for all related accidents, injuries, damages, maintenance and/or repairs associated with facility use.
