The City Council Workshop was held on Tuesday, January 25, 2022, in the Grover W. Taylor Council Chambers located at 8353 Sierra Avenue, Fontana, California. Mayor Warren called the meeting to order at 5:02 p.m. with all members of the City Council present.

The City Council Regular meeting agenda was received and there were no City Manager comments.

City Attorney Ruben Duran asked the Mayor and City Council to take an action to add the following item to the upcoming Closed Session meeting scheduled for January 25, 2022, at 6:00 p.m.

#### Lejins v. City of Long Beach

Essentially, the City Council will be asked if they are willing to sign a letter of support that will go to the California Supreme Court on behalf of the City of Long Beach and League of California Cities. This subsequent item requires a 4/5 vote to take immediate action and add this to the Closed Session meeting. This item does require immediate action of the Council, due to the appeal potentially being heard by the Supreme Court by end of week or early next.

Council Member Cothran requested that City staff further review the proposed designs and ensure that the history of Fontana remain displayed within the new layout of the Civic Center, i.e., steel beams and fruit trees. Council Member Sandoval also agreed with Council Member Cothran that the design should resemble the history of Fontana and proposed that staff connect with community partners for their inputs on design. Mayor Warren asked that City staff ensure to include the expansion of staff in the designs to allot for internal growth.

Fontana Honor Roll Organizing Committee Founder, Bill Freeman, presented a through presentation on behalf of the Fontana Honor Roll Organizing Committee regarding desires

of implementing a Veteran's Memorial within the Community for those service men and women, residents of Fontana, who served our Country. After the presentation, Mayor Warren informed Mr. Freeman that the concept of such memorial has been reviewed by the City Council, however, due to current plans of expansion and changes coming down the pipeline on City funded projects, the Council would like the Committee to hold off on location determination until further noticed by City staff.

**Mayor Warren opened the public hearing.**

**Deputy City Manager Burum and Senior Planner Rina Leung provided the staff report and answered questions of the City Council.**

**The following individuals spoke on this item:**

- 1. Miguel Aldana spoke on concerns of increased warehouse development within the community and thanked staff for implementing some environmental health safety for residents.**
- 2. Ana Gonzalez thanked the City and staff on bringing forward an Ordinance around the environmental impacts warehouse developments have on residents, however, feels that the City failed to obtain public input in assisting with the Ordinance development to better benefit the residents.**
- 3. Elizabeth Sena spoke on concerns of increased warehouse development within the community and feels that the Ordinance is misleading to the public on it's current language.**
- 4. Kareem Gongora, member of the Environmental Justice Group of the South Coast Air Quality Management District, representing the Fontana region, spoke on concerns of the Ordinance language presented and outlined further concerns with the warehouse development effects on residents health.**
- 5. Joaquin Castillejos thanked the City and staff on bringing forward an Ordinance addressing resident concerns with environmental impacts of warehouse developments, however, feels that the Ordinance is misleading and not sustainable.**
- 6. Jon Shardlow thanked the City and staff for maintaining a high standard throughout development and was taken back by some public comments received this evening.**
- 7. Matt Slowik outlined that the Ordinance proposed to the Council is one of many that have been gathered over decades of work on environmental**

and air quality studies and projects throughout the City.

8. **Andrea DeLeon, Executive Director of the Fontana Chamber of Commerce, spoke in support of the item before the Council and thanked City staff for proposing such an Ordinance to assist with the public concerns.**

**Mayor Warren closed the public hearing.**

**Mayor Warren addressed some of the public comments received regarding the process, identifying that the public has received multiple opportunities to provide input on this Ordinance at Planning Commission meetings, as well as by sending written correspondence to both Commissioner, Council members and City Staff.**

**Mayor Pro Tem Garcia clarified with the assistance of Deputy City Manager Burum that all the development projects throughout the City must follow all the rules, standards, and regulations presented by the South Coast Air Quality Management District and the California Resources Board. In addition, identified that this particular Ordinance enhances additional protection measures not required by either the South Coast Air Quality Management District or the California Resources Board.**

**Council Member Sandoval asked Deputy Manager Burum if staff have connected appropriately with businesses regarding this Ordinance, to ensure that City staff has done their due diligence on informing the public of these changes and impacts that it may have on their businesses.**

**Council Member Cothran confirmed with staff that the sign that will be added onto the corner will assist with blocking view of any vehicles potentially behind it.**

**Council Member Sandoval asked how many charging stations will be on-site for the property. Interim City Manager Shannon Yauchzee has announced that they look to put 2-3 Tesla charging stations on the property, voluntarily, but they will add the infrastructure for the potential addition of charging stations.**

**Mayor Warren closed the public hearing.**

**Mayor Warren commented on some of the public communications received this evening.**

**City Attorney Duran interjected and clarified that the Ordinance before the City Council is very narrow in scope, due to recent passing of State law. What is proposed to be changed in this Ordinance is not the provisions around the passed law, but the enforcement from County level to be transferred in-house to City level while still maintaining compliance with State law.**
