BEFORE YOU START...

Before you submit your application, use this checklist showing common issues that may affect project timelines and approvals. This will help avoid unnecessary delays and is especially important for minor projects completed without the help of a design professional.

- I obtain the necessary skills and experience to complete this project, or I have obtained the necessary assistance to complete this project.
- I checked if the zoning for the property allows for the proposed use and the requirements for the area. Contact Planning at (909) 350-6718.
- I reviewed the fees associated with this project and have the necessary funds or financing available.
- I checked the parking requirements, and the property has the available space to meet these requirements. Contact Planning at (909) 350-6718.
- I checked if the property is located in an environmentally sensitive habitat area or is home to an endangered species. Contact Planning at (909) 350-6718.
- I reviewed the property documents to ensure there are no easements located on the property or within the vicinity that may affect the project.
- I checked the availability, location, and size of the sewer lines and they will be sufficient for this project. Contact Engineering at (909) 350-7610.
- I checked if the project would require undergrounding of electrical utility poles. Contact Engineering at (909) 350-7610.
- I checked the requirements for off-site improvements such as sidewalks, street improvements, trenching, etc. Contact Engineering at (909) 350-7610.
- I checked the soil for contamination.
- I checked if there are any code compliance cases on the property.
- I checked the location and size of the water lines, and they will be sufficient for this project.
